### **Primary Purpose**

Primary Mental Health Team (PMHT) clinicians play a critical role in providing assessment, treatment and consultancy support to consumers who experience a 'high prevalence' mental health disorder, including but not restricted to depression and anxiety. Consumers are referred to the PMHT by their treating General Practitioner (GP), and are predominantly reviewed by PMHT clinicians co-located in General Practice. Working closely with the consumer and their referring GP, PMHT clinicians undertake a caseload, offering assessment and treatment recommendations, and short to medium term episodes of care.

PMHT clinicians additionally provide consultation support and education and training to other primary care providers. Consultation support to other primary care providers in particular enables the provision of specialist mental health consultation to consumers otherwise not directly engaged in treatment support by General Practice.

# Accountabilities and Key Results Areas

- Undertake a caseload within a consultancy model, providing clinical consultancy and advice to primary and specialist care providers.
- Deliver and review evidence based treatments to consumers within the primary care sector, and / or in other settings as indicated by clinical guidelines; such interventions will include assessment, and short and medium term (treatment) service delivery.
- Establish and maintain regular liaison with General Practitioners, and a broad range of community based agencies to assist with service development and provision.
- Provide General Practitioners and other primary care providers advice, consultation, and training as required.
- Develop, deliver and evaluate training and education programs as required.
- Work with consumers in a range of settings, predominantly in General Practice, in a manner that promotes hope, selfidentity, meaning and personal responsibility.
- Undertake role in a manner that is recovery oriented and trauma informed.
- Liaise with other community groups, agencies, individuals and networks to enhance service integration and educate other services about mental health issues.
- Complete all documentation according to legislative and service requirements, including direct data entry, completion of Electronic Health Record (EHR) entries, CMI contacts and outcome measures.
- Ensure an understanding and application of all relevant protocols and legislation.
